### ORDER

In terms of Section 14 (1) of the NCTE Act, 1993 Ratilal Vaghasia Smarak Trust Shri Saraswati Vidya Sankul, Dhoraji, Dist. Rajkot had submitted an application to the Western Regional Committee of NCTE for grant of recognition for starting PTC of two years duration from the academic session 2002-2003 with an annual intake of 50 students.

- On scrutiny of the application submitted by the institution, the documents attached therewith 2. and the input received from the visiting team, the Committee has noted the following:
  - The institution has acquired the land for setting up the teacher education (i) institution.
  - (ii) h The institution has constructed the building for conducting the course on the above mentioned land.
  - The institution has made arrangements for conducting the course in rented premises. The institution has created an Endowment Fund of Rs. 5.00 lakhs and a Reserve (iii) Fund of Rs. three lakhs.
  - The institution has initiated the process for recruitment of Principal/Head of (iv) Department and teachers for the said course.
  - Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Ratilal Vaghasia Smarak Trust Shri Saraswati Vidya Sankul, Dhoraji, Dist. Rajkot for PTC of two years duration from the academic session 2002-2003 with and annual intake of 50 students subjects to fuilfillment of the following.
  - That the institution will ensure that 06 (one Principal and 05 lecturers) faculty (a) members are in position for an intake of 50 students before commencement of the course and a report to this effect duly verified by the Director of Primary Education, Gujarat State shall be sent to the Committee within one month of commencement of the course.
  - The institution shall within one month of the receipt of recognition convert the (b) endowment fund account into a joint account to be operated along with an official of the Regional Committee.

(c) The institution shall shift to its own premises within three years from the date of recognition (In case the course is started in rented premises).

(d) The institution shall comply with the various other norms and standards as prescribed in

the NCTE Regulations.

- 4. Recognition is subject to the condition that the Board/Directorate shall ensure that, among other things, an institution has appointed required number of faculty members (including Principal/Head of Department) as per the norms of the NCTE/affiliating Board/Directorate of Education).
- Further, the recognition is subject to the fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- 6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university/State Directorate of Education to the appointment of faculty members and the statement of annual accounts duly audited by a Chartered Accountant.
- 7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
